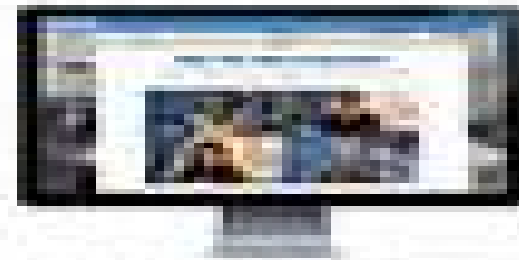

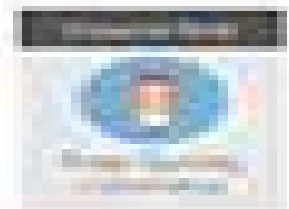
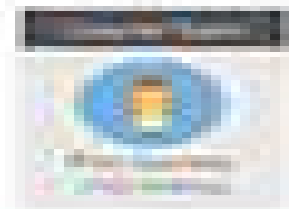

ecosystem It is not simply entrepreneurial finance VCs play a very important strategic role in commercializing technologies Just as importantly they employ specific strategies that we can learn and apply to our own entrepreneurial circumstances
