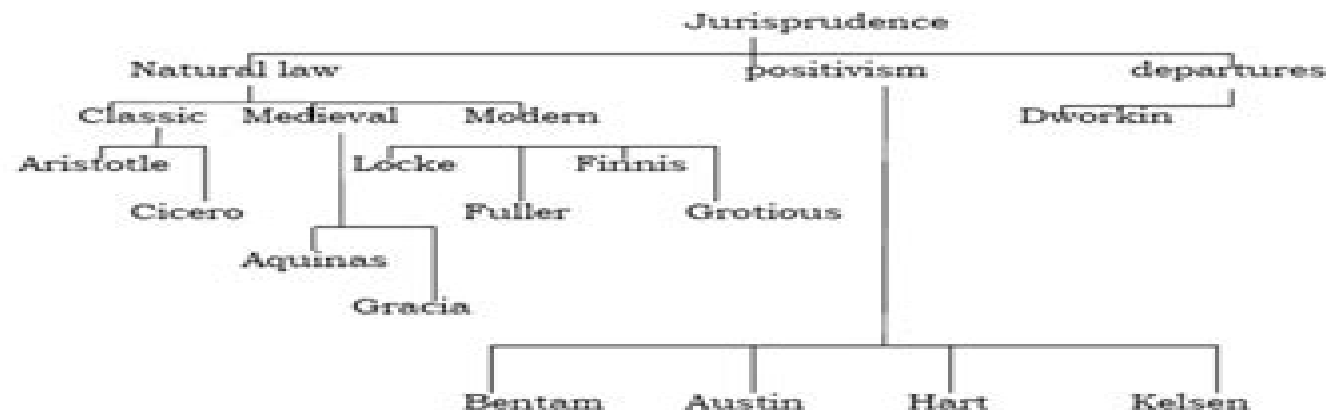


## **JURISPRUDENCE NOTES**

In a broad sense, the term jurisprudence may be applied to cover the whole range of enquiries about the nature and significance of law. In a narrow sense and the more appropriate sense to us, it covers the general intellectual enquiries about law other than the technical issues on specific propositions of law.
