

CLAUSE 23: REGULATIONS

- The Minister must make regulations after receipt of recommendations from the Board, regarding –
 - the types of matters for which aid is provided or not provided;
 - requirements an applicant must comply with to qualify for aid;
 - the policy relating to approval, refusal and termination of aid.
- Regulations made must be tabled in Parliament by the Minister for approval.
- The regulations may provide that any person who contravenes a provision thereof or fails to comply therewith, is guilty of an offence.
- There is no provision in the Act for regulations.
