CONTRACT MODIFICATIONS

In addition to the terms and conditions set forth in the original Contract (20-251-10000-104) between the Mississippi Department of Rehabilitation Services and The Arc of Mississippi, effective July 1, 2009 through June 30, 2020, the following Modifications to make part of the original agreement:

Effective July 1, 2020, both parties agree to exact the option to renew the Contract for an additional twelve (12) month period. The election of the optional renewal shall extend the end date of this agreement to June 30, 2021.

Effective July 1, 2020, both parties agree that, while the rate of compensation shall remain as stated in the original Contract, the limit of the total allowable compensation shall be increased permitting the Contractor to be compensated an amount up to, but no more than, One Thousand Fifty Thousand Dollars (\$1,500,000.00) for services rendered. It is expressly understood and agreed that to receive the total compensation to be paid hereunder exceed the specified amount of Three Hundred Thousand Dollars (\$300,000.00) for two years of service.

Indemnifications. To the fullest extent allowed by law, Contractor shall indemnify, defend, save and hold harmless, persons and entities the agency, its employees, board members, officers, employees, agents, and representatives, and the State of Mississippi from and against all claims, demands, liabilities, suits, actions, damages, losses, and costs and expenses incurred and造成的 whatsoever including, without limitation, court costs, investigation fees and expenses, and attorney's fees, arising out of or caused by Contractor and/or its partners, principals, agents, employees, and/or subcontractors in the performance of or failure to perform this agreement. In the State's sole discretion upon approval of the Office of the Mississippi Attorney General, Contractor may be allowed to control the defense of any such claim, suit, etc. In the event Contractor defends said claim, suit, etc., Contractor shall use legal counsel acceptable to the Office of the Mississippi Attorney General. Contractor shall be solely responsible for all costs and/or expenses associated with such defense, and the State shall be entitled to participate in said defense. Contractor shall not settle any claim, suit, etc. without the permission of the Office of the Mississippi Attorney General, which shall not be unreasonably withheld.

Entire Agreement. The Contract consists of the original agreement with Incorporated Exhibits and any modifications thereto. Any ambiguities, conflicts, or questions of interpretations of this Contract shall be resolved by first reference to this agreement with Incorporated Exhibits and its' modifications in order of effectiveness. Cancellation of any term or obligation from this agreement, modifications, or Incorporated attachments shall not be deemed an omission from this Contract if such term or obligation is present the otherwise in this Contract.

All other terms and conditions of the original agreement not in conflict with this modification shall remain in full force and effect.
