Geoengineering Kelsi Bracmort, 2014-12-31 Climate change policies at both the national and international levels have traditionally focused on measures to mitigate greenhouse gas GHG emissions and to adapt to the actual or anticipated impacts of changes in the climate. As a participant in several international agreements on climate change, the United States has joined with other nations to express concern about climate change. Some recent technological advances and hypotheses generally referred to as geoengineering technologies have created alternatives to traditional approaches to mitigating climate change. If deployed, these new technologies could modify the Earth's climate on a large scale. Moreover, these new technologies may become available to foreign governments and entities in the private sector to use unilaterally without authorization from the United States government or an international treaty, as was done in the summer of 2012 when an American citizen conducted an ocean fertilization experiment off the coast of Canada.

The term geoengineering describes this array of technologies that aim through large scale and deliberate modifications of the Earth's energy balance to reduce temperatures and counteract anthropogenic climate change. Moreover, very few studies have been published that document the cost, environmental effects, sociopolitical impacts, and legal implications of geoengineering.
